- Fire Laws, etc.: All pertinent fire codes, laws, ordinances and regulations pertaining to health, fire protection and public safety must be adhered to at all times.
- Exhibitor must leave assigned vendor space as found.
- Payment in full is required with this application in order to be accepted and approved. No refunds will be issued after July 1st, 2012.
- Insurance: All vendors must carry their own insurance. (Please see Release and Waiver of Liability regarding insurance.) This form must be signed and returned with this application and your payment.
- Failure to comply with any of these provisions will result in removal of the event without a refund.
- 24 hour security is provided on premises on Fri and Sat but the SDCC is not responsible for items lost or stolen, or vehicles left unattended.
- Food Vendors must contact the Nevada State Health Division and obtain an off site health permit. This cost is NOT included in the vendor fees.
- 110V electricity is provided at an additional cost if you want it (additional fee does not apply to food vendors) but you must bring your own extension cords.
- Decisions of the SDCC management are final.
